## PURCHASING

We accept Wix secure online payment system. Wix is accepting the following payment methods: Visa, Mastercard, AMEX, Maestro, Diner's Club and PayPal.

All Purchases can be made by adding your chosen items to the shopping cart. You can add note to seller in the cart and also choose quantity of the product and then proceed to check out. You will then be asked to input details needed to complete the order.

Cancellations are not excepted once payment is received.

All prices are quoted in GBP (£). While your purchase and fees will be shown in USD, the total payout amount will be shown in GBP.

Conversion from USD to GBP happening at the time of purchase for credit card transactions.

### Placing your Order

Once we have received your order you will receive a notification email. A purchase contract between ZeeCee Boutique and you is only made once the item has been dispatched. Therefore if your order is cancelled or it cannot be accepted, no purchase contract will have been made. Occasionally we may not be able to accept an order for the following reasons:

If we do not currently hold stock of your item

If payment for the item has not been authorised

## CANCELLATIONS

The Consumer Protection (Distance Selling) Regulations 2000 will apply to these Terms. These regulations entitle consumers to cancel an order during the period set out in below, and receive a refund. There are exceptions to which this cancellation right does not apply, which include but are not limited to made-to-order or customised products. All our products are hand-made to order. Once you place an order and confirm the details in writing for any customised products and make payment in respect of it, we will take that as your confirmation to us to commence making your product, in which case due to the very individual nature of customised products which cannot be re-sold, you will no longer be able to cancel the order.

Your legal right to cancel an order starts from the date on which we receive payment in full in respect of your order, which is when the contract between us is formed and is available for a period of 7 working days. Failure to contact us after 7 working days after purchase to cancel your order will incur 50% cancellation fee. All sales are final.

up to 250 Products, around 6 weeks from the date of your Order;

## RETURNS
